

## **Health Provider Bargaining Unit**

### **Bargaining continues**

Your SGEU Negotiating Committee met with Saskatchewan Association of Health Organizers (SAHO) June 13-14 in Saskatoon, to continue the process of bargaining for a new collective agreement.

We have tentatively agreed to some housekeeping changes that reflect the new Saskatchewan Employment Act, and we shared information with SAHO regarding some of our individual proposals. SAHO also presented us with a list of letters of understanding that we need to review.

All of the rollbacks that were previously proposed by the employer are still on the table. We have not removed our bargaining proposals either.

### **Next steps**

SAHO confirmed next bargaining dates for July 4-6 in Saskatoon and July 25-27 in Regina. Our coalition partners, CUPE and SEIU-WEST, will also be present to bargain on those dates.
